Whereas, McFarland Johnson has since completed said design, coordinated the bidding process and recommends that the following low bidders be awarded the construction contracts for the base bid: Black Horse Group, LLC, for general construction in the amount of \$2,179,286, Ontario HVAC Solutions, Inc. for mechanical and plumbing in the amount of \$240,354 and \$127,000 respectively, and Northern Pioneer Contractors, Inc, for electrical in the amount of \$343,700, and

Whereas, McFarland Johnson will provide Construction and Grant Administration at a cost of \$320,000, and

Whereas, It is necessary to authorize the construction contracts with these companies, and to amend the 2021 Capital Budget, and

Whereas, The Jefferson County local share of the construction project costs will be \$1,734,299, and

Whereas, Funds are available in the Airport Facility Capital account from the Coronavirus Response and Relief Supplemental Appropriation Act and the Coronavirus Aid, Relief, and Economic Security Act.



The Stonegarden FY 2019 Grant has been modified to reflect the deletion of LPR equipment, and substituting new outfitted UTV's (Utility Task Vehicle). Our agency currently owns four Polaris all-terrain vehicles, each being twelve years old. Although our current fleet is still operational, they are starting to need more complex and costly repairs. It appears to be a wise proactive measure to replace them with this grant at this time.
