Authorizing Agreements for Provision of Services to Elderly of Jefferson County

Whereas, The Jefferson County Office for the Aging (OFA) works for the establishment and expansion of programs and services which assist older persons in the areas of their most urgent needs, and

Whereas, OFA is eligible to receive State and Federal funds for the purpose of providing such needed programs and services to elderly residents of Jefferson County, and

Community Medicine and Paramedicine Pilot Initiative Briefing Summary

Overview:

Community Paramedicine is a healthcare delivery model that increases access to basic services by utilizing specially trained emergency medical service (EMS) providers in an appropriate, expanded role. Community Paramedics care for patients at home or in other non-urgent settings outside of a hospital under the supervision of a physician or advance practice provider. Community Paramedics can expand the reach of primary care and public health services by using EMS personnel to perform patient assessments. The Community Paramedicine programs can fill local healthcare gaps with EMS personnel through non-emergency interaction with patients in the community, integration and coordination with a variety of needed services, and improved patient navigation.

The Home Care Association of New York State and the Iroquois Healthcare Association have teamed up to pilot three community medicine and Paramedicine programs with grant funds received from the Mother Cabrini Health Foundation. Through this grant, the association will collaborate with hospitals, home care agencies and emergency service organizations to conduct pilots in small, rural community regions of the state. Through design and creation of collaborative, community-centric models of community medicine and Paramedicine, core health sector partners will come together to meet the needs of their communities.

Jefferson County has been selected as one of the three community medicine and Paramedicine program pilot areas. The collaboration will occur between the Jefferson County hospitals, five Emergency Medical Service Agencies, Fort Drum Regional Health Planning Organization (FDRHPO), Jefferson County Emergency Medical Services s and the Jefferson County Public Health Service (JCPHS). The partners will work together to develop and implement a comprehensive model for Jefferson County. An award in the amount of \$250,000 will cover the period of January 1 – December 31, 2022.
