### LOCAL LAWS, RESOLUTIONS AND MOTIONS

#### Local Law Intro. No. 1 of 2022

### A Local Law Reapportioning the Board of Legislators of the County of Jefferson Based Upon the 2020 Federal Decennial Census (Text of Local Law in June, 2022 Session)

Chairman Johnson entertained a motion to take the Local Law off the table for adoption. Such motion was made by Legislator Maxon and seconded by Legislator Jareo. All members present voted aye.

Legislator Maxon was pleased with how the districts turned out and thanked Planning Department Head Michael Bourcy and the Ad Hoc Committee on Redistricting for being so responsive to questions, coming up with drafts and considering alternatives. He felt the redistribution was very fair and equitable especially given the new constraints.

Legislator Peck as a member of the Ad Hoc Committee appreciated the comments of Legislator Maxon said they came up with maps as clean and concise as they could in keeping the current districts. He commended both staff and the Committee for the creation of the new maps.

Administrator Hagemann advised that many counties have hired consultants at a significant expense to do their redistricting maps and there are many counties that are no where near finishing this exercise. He gave kudos to staff and Board members who have worked hard to put this package together.

### **Resolution No. 223**

### Urging the New York State Legislature to Amend and Reform State Law in Regard to the Living Situations for Persons Designated as Sex Offenders.

Whereas, New York State enacted the Sexual Offender Registration Act requiring individuals convicted of certain crimes to report their place of residence to the NYS Division of Criminal Justice Services, and

Whereas, New York State further enacted the Sexual Assault Reform Act requiring that as a condition of probation or parole, level three sex offenders are restricted from entering within a certain distance of a school grounds, and

Whereas, Children congregate in facilities and locations other than school grounds on a regular basis, such as playgrounds or recreational fields, and said locations deserve consideration for protection from the presence of sex offenders on the same basis as school grounds, and

Whereas, Jefferson County has experienced a significant reduction in single occupancy housing in recent years due to the destruction of multi unit housing by fire and condemnation for building code violations, and

Whereas, Contemporaneously the market rate cost for single occupancy housing in Jefferson County has risen to exceed the benefit paid under Social Services Law for home relief, resulting in a marked increase in homelessness and demand for emergency assistance from the local Social Services unit, and

Whereas, A Portion of the homeless in need of emergency housing assistance from the local Social Services unit are persons classified as sexual offenders and the local Commissioner of Social Services is required to find temporary housing for all eligible individuals, including those who are sex offenders, pursuant to statute and regulation (18 NYCRR §352.36), and

Whereas, In Most communities the only affordable and available temporary emergency housing is in a motel setting which is proximate to a school, playground, recreational field, or nursing home/citizens centers.

Now, Therefore, Be It Resolved, That the Jefferson County Board of Legislators urges the New York State Legislature to reform and amend the Sexual Offender Registration Act and Sexual Assault Reform Act to provide for a safety zone around schools, playgrounds or recreational fields at which children congregate and nursing home/citizens centers that they may not be entered by registered sex offenders, and it is further

Resolved, The State Legislature is further urged to increase the home relief shelter allowance benefit for single individuals so that permanent housing situations may become available to single individuals and thereby relieve the demand for temporary emergency housing in motel settings, and it is further

Resolved, That this resolution shall be delivered to the Speaker of the NYS Assembly, President Pro-Tem of the NYS Senate and NYS Governor.

Seconded by Legislator: Corey Y. Grant

Legislator Peck thanked staff for drafting this resolution and said he hoped the State could change this legislation as it is a matter of health, welfare and security of our communities. He pointed out that following an action of the Supreme Court on guns, the State Legislature almost immediately passed legislation restricting access of individuals with a weapon from playgrounds, parks, zoos, etc., however level two and level three sex offenders can still congregate in those areas and are only restricted from schools. He hoped the State would react as quickly to this resolution as they did the decision of the Supreme Court on guns.

Legislator Doldo agreed with Legislator Peck's comments, and made a motion to amend the third paragraph up from the bottom to read "fields at which children congregate *and* or nursing home/citizens centers that *they* may not be", the motion was seconded by Legislator Peck and unanimously carried by the Board. (The above resolution contains the amendments).

Legislator Maxon thanked the community for bringing this issue to the Board's attention, repeatedly and passionately. He said it is important for citizens to be able to petition their

government for a redress of grievances. He was glad the Board could take up the cause, make an administrative change in policy, and send this off to Albany to try and get the State Law changed.

All members present voted aye on Resolution No. 223, as amended.

Chairman Johnson advised that he is reinstating the Ad Hoc Committee for Legislative Appointments with the same members; Legislators Drake, Jareo, Calarco, Cantwell and Peck. He said the Committee will consider any open position, this will exclude reappointments and appointments specifically assigned to the Chairman of the Board. The Board Office has a Committee assignment list which organizes the appointments the Board of Legislators makes. The Committee consists of five members representing both parties and geographic areas of the County. The charge is to generate a list of people to be considered and when an opening occurs, vet a candidate to be recommended to the jurisdictional committee.

Legislator Drake reminded legislators that five years ago on July 10<sup>th</sup> Joel Davis was killed in the line of duty and how important it is for police officers as their community still hurts from Joel's death. He hopes no one is ever killed in the line of duty in Jefferson County again.

Legislator Jareo thanked the Chairman for reinstating the Ad Hoc Committee as he feels it is one of the most important things that the Board does as a body; to put good people on these boards that have the potential to spend millions of dollars of public money in the community. It is important that these people are vetted and the best people are utilized that are willing to do it. He also asked that when the full Board agenda comes out a copy of all the resolutions be attached to it as well. Mr. Hagemann advised that the agenda with a complete set of resolutions is posted on the website and Legislator Jareo said that would suffice.

Legislator Maxon reminded everyone of the opening of the Jefferson County Fair next Tuesday, July 12<sup>th</sup> at 6:30 p.m., and hoped to see everyone there.

There being no further business of the Board, on a motion by Legislator Cantwell seconded by Legislator Doldo and unanimously carried, the meeting was adjourned at 6:25 p.m.
