Concurring in Settlement of Tax Certiorari Proceedings and Authorizing Refund of Taxes in Connection Therewith (Rite Aid/Walgreen Co.).

Resolution No. 235

Authorizing Agreement with Axon Enterprise Inc. for Provision of Body Worn Cameras for the Jefferson County Sheriff's Office

Whereas, By Resolution 80 of 2021, This Board of Legislators adopted the Jefferson County Police Reform and Reinvention Collaborative Plan which included the recommendation that the Sheriff determine if body worn cameras will serve the agency's purposes and the public, and

Whereas, Funding for such cameras was requested by the Sheriff and included in the 2022 Adopted County Budget, and

Whereas, The Purchasing Agent has determined that Axon Enterprise, Inc. is a sole source provider of the body worn cameras and designated associated items, and

Whereas, Axon Enterprise Inc. will supply the cameras and related equipment, software compatible with other law enforcement agencies, supplies and training to the Jefferson County Sheriff's Office, and

Whereas, It is most affordable to enter a five-year contract at \$107,078.87 annually, which is recommended by the Sheriff and Purchasing Agent.

Now, Therefore, Be it Resolved, That this Board of Legislators hereby authorizes the award of a contract to Axon Enterprise, Inc. for provision of body worn cameras and related equipment for the period October 1, 2022 through September 30, 2027, and be it further

Resolved, That the Chairman of the Board is hereby authorized to execute said agreement on behalf of Jefferson County subject to approval by the County Attorney as to form and content.

Legislator Maxon said the Sheriff's Department being outfitted with body cameras is a good idea and is a reasonable expense to bear but asked if there was a policy that defined if the videos are FOILable, how long the video is going to be retained, etc. Administrator Hagemann said the Sheriff's Department is developing a policy. Legislator Gray asked if this Board would be adopting the policy or if it will be an internal operating policy. Administrator Hagemann said it would be an internal operating policy of the Sheriff's Department.

Legislator Jareo asked if it would be the authority of the Sheriff to write the policy or if the authority rests with the Board of Legislators. Administrator Hagemann speculated that it was the authority of the Sheriff. County Attorney Paulsen was not positive, but said insofar as they are used in law enforcement it is possible that it is completely within the realm of the Sheriff; he said he would have to check on it and get back to legislators. Mr. Hagemann added that the policies can be shared with the Board once they are established.

Legislator Gray said the operation of the cameras themselves (when they turn on, when they turn off) may be an internal policy, but the availability of the recordings to the public may be more of a Board level policy. In terms of the availability through FOIL County Attorney Paulsen said any material that is collected by a law enforcement agency for a pending investigation would not be available through FOIL, however once a conviction has been made and the case closed, that type of material is then FOILable. Legislator Gray stated that there have been instances where other agencies have released the footage to form public opinion before any court proceedings. He said the purpose of having the videos needs to be defined (for law enforcement purposes) before they are used, along with and a policy and procedure for how and when the footage is released.

Legislator Maxon recalled that Civil Rights Law 50(a) was changed recently making certain personnel records of law enforcement personnel available that resulted in a number of law enforcement agencies being inundated with FOIL requests for a lot of different materials. With the videos, he would be worried that people may try to sway public opinion one way or the other and because it is the justice system you want it to be used in as neutral a way as possible. He was interested in the policies that the Sheriff will adopt (that other Sheriff's Offices use) and at what point the Board gets involved in having those discussions about when the footage can be released to the public

Legislator Doldo asked if we know when the body cameras will start being used. Administrator Hagemann said he was not positive but possibly late this year, or early 2023.

Legislator Peck asked if the body cameras were a budgeted item or an unexpected expense, and who the FOIL Officer is for the Sheriff's Department. Mr. Hagemann said utilizing body cams stems from a recommendation made last year and money was placed in the 2022 Budget, and the FOIL Officer for the entire County is the County Administrator so no matter what department a request involves, it is answered by the Administrator.

With regard to the announcement that \$2.9 million in American Rescue Act Plan funding was being awarded to the North Country Home Consortium to assist in the homelessness crisis, Administrator Hagemann related that the funds will be allocated through the Consortium which includes Jefferson, St. Lawrence and Lewis counties, and some administrative functions will be performed by the Development Authority of the North County (DANC) who are reviewing a number of potential uses for all three counties. He said DANC is not the decision making body for the funds, that will be the Consortium. Legislator Peck expressed frustration that we are getting closer to winter and running out of time, yet we still do not have a report from the Homelessness Coalition that has been working for some time on a solution to the homeless problem.

There being no further business of the Board, on a motion by Legislator Maxon seconded by Legislator Ferris and unanimously carried, the meeting was adjourned at 6:25 p.m.
