Resolution No. 342

Affirming Schedule for Funeral Home Rates in Relation to Indigent Burials

By Legislator: Jeremiah J. Maxon

Whereas, New York State Social Services Law S. 141 requires county departments of Social Services to pay the reasonable expenses for Indigent Burials, and

Whereas, The burial expenses for which Jefferson County Department of Social Services is responsible include reasonable costs incident to the proper burial of a deceased indigent person, and

Whereas, The funeral directors in Jefferson County work with the DSS Commissioner to tend to the needs of the decedents and their families, and

Whereas, Jefferson County Board of Legislators and DSS Commissioner have recognized that the costs to funeral homes have increased substantially while payment rates have not been adjusted, and

Whereas, The 2024 DSS Budget includes funding to increase the amounts paid to funeral homes.

Now, Therefore, Be It Resolved, That this Board of Legislators affirms the increase to the Funeral Home rate for basic service to \$2,400 effective January 1, 2024, and be it further

Resolved, That the DSS Commissioner include rate increases in future years in accordance with the Consumer Price Index (CPI-W) with a 2% cap, in order to maintain parity with increasing costs, and be it further

Resolved, That all rates for related equipment and other services required by state and local law

be subject to negotiation with the DSS Commissioner.

Seconded by Legislator: Corey Y. Grant

All members present voted aye except Legislator Calarco who abstained from voting due to a conflict of interest.

County Attorney Paulsen advised that he was contacted by a constituent who questioned a flaw in the procedures that the County was following regarding the Management and Management Confidential salary plan being adopted by a resolution vs. a local law. After doing research he said the constituent had a point in that the annual cost of living increase to Management and Management Confidential employees has been done by resolution going back 30 years or so, prior to that it had been by Local Law. He said there is nothing wrong with doing it by resolution insofar as it applies to those management employees who either do not have a specific term of office, or those who are beginning a term of office at the time the new compensation schedule goes into effect. However, he said there is a third group which is those elected and appointed officers who have a specific term and are in the middle of a term at any given time when this Board makes a change to the compensation schedule; County Law says in those circumstances that category must be done by the local law procedure.

Attorney Paulsen said because Resolution 300 covers all three groups mentioned his recommendation is that the County converts to reviewing and approving the compensation plan as a local law so there is no question as to the applicability to those individuals who are in the middle of their term. He presumed that it was not the Board's intention to treat the group in the middle of their term any differently then anyone else by proceeding with the resolution and segregating them off, which would inevitably lead to differential treatment. Therefore, his recommendation is that the Board waive the Standing Rules at this time to introduce the local law, schedule a public hearing to be held at a special meeting of the Board to be held after seven days, which is the required waiting period after a local law is introduced. The proposed special meeting could be held on December 20, 2023. With regard to the resolution, he suggested tabling it, and if the local law passes it can be left to wither after the 90 days passes and it does not have to be called back from the table.

- Section 2. For the calendar year 2024 the flat professional schedule and part time security personnel rates are increased by 3.0%.
- Section 3. The Employment Policy Manual for Department Heads, Management Employees and Management Confidential Employees Section II. 2. Longevity is amended to read: "Employees who have been continuously employed on a full time basis with the County receive a longevity incentive of 4% of the base salary for their grade after 5, 10, 15, and 20 years of service. The longevity incentive is added to their salary in the payroll period nearest their longevity anniversary date."
- Section 4. Upon its effective date, and otherwise applicable to the first payroll period commencing January 1, 2024, the Jefferson County management and management confidential salary schedule shall apply to all positions identified therein and shall continue in effect unless or until amended, repealed or replaced.

- Section 5. This local law is adopted subject to a permissive referendum as to the change in salary of an elected or appointed officer effective during their term of office and the Clerk of the Board is directed to publish notice of the same as required by law.
- Section 6. All local laws and resolutions of the Board of Legislators of Jefferson County, to the extent that the same are inconsistent with this local law, are hereby superceded by this local law.
- Section 7. The Employment Policy Manual for Department Heads, Management Employees and Management Confidential employees shall be amended pursuant to this local law.
- Section 8. If any clause, sentence, paragraph, subdivision, section, or part of this law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by a court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstances directly involved in the controversy in which such order or judgement shall be rendered.
- Section 9. This local law shall become effective in accordance with the provisions of the Municipal Home Rule Law of the State of New York.

Now, Therefore Be It Resolved, That this Board of Legislators will hold a Special Session on Wednesday, December 20th, 2023 directly after said Public Hearing for the purpose of considering Local Law Introduction No. 5 of 2023.

All members present voted aye.

Chairman Johnson presented outgoing Legislators Drake and Maxon with plaques in recognition of their service and time on the Board of Legislators; Legislator Drake from 2009-2023 and Legislator Maxon from 2014-2023.

Legislator Drake said after 15 years on the Board he made the decision in January, 2023 not to run for another term. He thanked Jefferson County employees that make the County operate efficiently as he believed them to be motivated, dedicated and a skilled work force. He thanked the Department Heads and Administration for their dedication to their jobs and to serving the people of our County. He admired their zeal, commitment and leadership in running such a large organization so smoothly. He thanked his fellow legislators for putting up with the lone Democrat. He urged Board members to continue their support for JCC which he considered the County's greatest asset. He bid everyone farewell and "may the force be with you".

Legislator Maxon expressed his appreciation to Board members and said he would limit his comments to members as Legislator Drake had already thanked the employees, managers and administrators. He said it has been a pleasure serving with everyone, and there is a time and season for everything. In the Spring he had a conversation with his wife about priorities and those priorities did not involve partisan politics so they would let the election run its course. He said ten years ago when he came on the Board it was very difficult to express any alternative opinions and there were a few contentious years. In the last four years, certainly the last two years with Chairman Johnson the entire atmosphere and culture of the Board has changed. He said it is a lot more free to deal with dissenting opinions, to accept and listen first and not immediately ask for uniformity. Former Legislator Robert Thomas told him once not to be afraid of an 8 to 7 vote; leave differences of opinion on the floor your friendship is what matters, and working together for the good of the people in the County is what you will be remembered for.

Legislator Jareo related a story of when he and Legislator Maxon were running for office and first on the Board together. He said over the ten years they have become very close friends and colleagues and thanked Legislator Maxon for everything he has done over the last 10 years and wished him well.

There being no further business of the Board, on a motion by legislator Maxon seconded by Legislator Potter and unanimously carried, the meeting was adjourned at 3:48 p.m
