Whereas The PFC will continue to be used to fund FAA-approved projects that enhance safety, security, or capacity, reduce noise, or increase air carrier competition, and

Whereas, Public notification and air carrier coordination periods were concluded on January 3, 2024 and it is now necessary to execute the application documents that will extend PFC collections until January 1, 2031.

Re-Authorizing an Agreement with Jefferson County Stormwater Municipal Coalition

Whereas, The United States Bureau of the Census has designated an area of Jefferson County as an "urbanized area" in excess of 50,000 residents based on the 2010 Census population data, and

Whereas, The U. S. Environmental Protection Agency requires that municipalities which operate a municipal storm water sewer system (Municipal Separate Storm Sewer System (MS4)) within said area are required to obtain a permit through the New York State Department of Environmental Conservation (DEC), to discharge stormwater, for the purpose of reducing pollution, and

Whereas, The DEC has informed the County that it must obtain said permit and develop and implement a plan for those areas within the urbanized area in which it is responsible for a stormwater system, and

Whereas, The Towns of LeRay, Rutland and Watertown, the Villages of Black River, Brownville, Carthage and West Carthage, City of Watertown and Jefferson County have formed a coalition to combine their resources for the purpose of developing and implementing their plans, and

Whereas, By Resolution 217 of 2014, This Board of Legislators authorized an agreement with said Jefferson County Stormwater Coalition, subsequently re-authorized by Resolution 259 of 2017, and

Whereas, The Jefferson County Soil & Water Conservation District is acting as staff consultants to said coalition, and

Whereas, There is a membership fee of \$500 annually for 2023 and 2024, and up to \$3,500 annually thereafter for said coalition members, and

Whereas, It is in the best interest of Jefferson County to remain in said coalition.

Now, Therefore, Be It Resolved, That Jefferson County re-authorizes said agreement with the Jefferson County Stormwater Coalition for the period January 1, 2023 through December 31, 2027, and that the Chairman of the Board of Legislators is hereby authorized to execute said agreement on behalf of the County, subject to the review of the County Attorney as to form and content.

Seniors Helping Seniors, Watertown, NY at a blended hourly rate of \$36.50 per hour for the

period of January 1, 2024 through December 31, 2025, for the provision of housekeeping/chore, personal care and caregiver respite services for persons 60 years of age or older, and be it further

JEFFERSON COUNTY DEPARTMENT OF SOCIAL SERVICES INDIGENT BURIAL RATES (Effective 1/1/2024)

1. <u>Professional Services:</u> General: \$2,400.00

Stillborn Burial: \$550.00

Services including the removal of remains, arrangements, embalming, personnel costs, preparation and filing of death certificate, and the provision of a cremation container (if applicable).

Definitions:

<u>Arrangements</u>: Basic arrangements including the funeral director, other staff, equipment and facilities to respond to the initial request for services, the arrangement conference, securing of necessary authorizations and coordination of service plans with parties involved in the final disposition of the deceased.

<u>Embalming</u>: Includes the use of the preparation room with services to include topical disinfection custodial care, dressing/casketing, cosmetology, and restoration.

2. Deliverables:

- a) The cost of a basic minimum casket shall be paid by the County at the invoice cost to the funeral home or service.
- b) A basic minimum grave vault or liner shall be provided and paid by the County at the invoice cost to the funeral home or service.
- c) Cemetery equipment and delivery and placement of a vault or liner shall be paid by the County at the actual cost to funeral home or service.

3. Miscellaneous Items:

a) Mileage for transportation of remains shall be billed at \$1.85 per loaded mile.

- b) Oversized casket, if required, shall be paid at the invoice cost to the funeral home or service. Prior authorization of the Commissioner of Social Services is required.
- c) Cemetery fees, including the cost of the grave plot and any opening or closing fees of the Cemetery shall be a direct cost billed and paid by the Commissioner of Social Services. Said fees shall not exceed \$633.00 for interment of adult direct burial, adult cremation burial, and stillborn burial.
- d) Cost of a winter vault, not to exceed \$100, shall be a direct cost billed to the Commissioner of Social Services.
- e) Crematory Fees shall be a direct charge billed to and paid by the Commissioner of Social Services.
- 4. The total cost of services and items identified above shall constitute the maximum obligation of the County to reimburse the costs of an indigent burial.
- 5. The fees for professional services shall be subject to a 2% annual increase to be effective on the first day of January for each calendar year.

6. Supplementation:

A funeral home or service may go above and beyond at the request of next of kin at their own discretion. Any services other than a direct burial or cremation would fall under the category of supplementation (e.g. calling hours, funeral or memorial service, grave side services, flowers, obituary cost, etc.). Such supplementation is the financial liability of the parties making the arrangements and the funeral home or service. Payment for those services should come directly from your general price list (GPL) or a lesser amount for the individual items selected or negotiated.

Patient Incidental Accounts (PIA) are not to be used as supplementation.

7. Next of Kin Liability:

Social Services Law §101, <u>Liability of Relatives to Support</u>: Except as otherwise provided by law, the spouse or parent of a recipient of public assistance or care of a person liable to become in need thereof shall, if of sufficient ability, be responsible for the support of such person, provided that a parent shall be responsible only for the support of a child under the age of twenty-one years. Stepparents shall in like manner be responsible for the support of stepchildren under the age of twenty-one years. Nothing herein shall impose any liability upon a person to support the adopted child of his or her spouse if such child was adopted after and the adopting spouse is living separate and apart from the non-adopting spouse pursuant to a legally recognizable separation agreement or decree

under domestic relations law. Such liability shall not be imposed for so long as the spouses remain separate and apart after the adoption.

8. Funeral Trust:

Deceased individuals who have pre-arranged under a funeral or final needs trust for the expense of arrangements and interment: Trust funds must be utilized in the first instance for final arrangements and burial.

Legislator Doldo thanked everyone involved who helped put the resolution together and the funeral homes for coming to an agreement with the County in taking care of indigent burials. He said many of the indigent burials are due to drug overdoses and he wondered if it was possible for the County to use money received from the Opioid lawsuits to pay for the burials instead of taxpayer dollars. He said he doesn't need an answer now, but thought it should be looked at.

Legislator Calarco said she would abstain from voting on this resolution due to a conflict of interest.

Whereas, The Public Health Service is experiencing difficulty recruiting and retaining nurses, resulting in a large number of vacancies and comparisons with other local organizations that are hiring nurses led to discussion with CSEA regarding these positions, and

Whereas, By Resolution 154 of 2018, this Board of Legislators accepted one-time funding used to provide retention and recruitment incentives for recently hired nurses and new nurses pursuant to a Memorandum Of Understanding (MOU) developed between CSEA and Jefferson County, and

Whereas, It is desirable to provide for ongoing funding to provide retention and recruitment incentives pursuant to a comparable MOU developed between CSEA and Jefferson County, and

Whereas, By Resolution 105 of 2022, this Board of Legislators authorized an employment agreement with CSEA, and it is desirable to change the grades of Public Health nursing positions within said agreement in order to be more competitive and fill vacant positions.

Now, Therefore, Be It Resolved, That the Human Resources Director is authorized to execute said MOU to include recruitment and retention incentives, and be it further

Resolved, That the Grades for the following positions will be:

Licensed Practical Nurse

Grade 12

Registered Professional Nurse

Grade 23

Public Health Nurse

Grade 24

Seconded by Legislator: Tina Bartlett-Bearup

Legislator Montigelli said a lot of work and money has gone into trying to find ways to attract and retain employees for these positions and he said this resolution provides the best way to address that, and he hoped it would attract some quality candidates for the positions. All members present voted aye.

Legislator Montigelli noted a success story of the Stormwater Coalition was that they received a grant to buy a vaccuum truck. It is the County's responsibility to store the truck and through shared services agreements with the municipalities that belong to the Coalition, any of them can use it.

There being no further business of the Board, on a motion by Legislator Doldo seconded by Legislator Ferris and unanimously carried, the meeting was adjourned at 6:25 p.m.
