Chairman Peck called the meeting to order at 6:05 p.m. and offered privilege of the floor.

Keith Kilgore, 25477 Huntley Lane, Great Bend, NY addressed the Committee about an unborn child's right to life. He said the 14th Amendment of the Bill of Rights which is cited in the Roe v. Wade decision does not contain anything relevant to the right of privacy or abortion. And contrary to what the justices said in Roe v. Wade, the US Constitution explicitly protects the life of an unborn child in the Preamble; specifically "the blessings of liberty to ourselves and *our posterity*", as the unborn are our posterity.

Chairman Peck declared the minutes of the December meeting approved as written in the absence of objection or correction.

Chairman Peck introduced a resolution amending the 2018 County Budget to recognize additional state aid and authorizing amended agreement with the Children's Home in relation thereto and entertained a motion for consideration. A motion was duly made by Legislator Doldo seconded by Legislator Nabywaniec and there being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Peck introduced a resolution authorizing agreement in relation to immunization action plan funding and entertained a motion for consideration. A motion was duly made by Legislator Fitzpatrick seconded by Legislator Maxon and there being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Peck introduced a resolution accepting funding in connection with NYSDOH local health department performance incentive initiative and amending the 2018 County Budget in relation thereto and entertained a motion for consideration. A motion was duly made by Legislator Maxon seconded by Legislator Doldo and there being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Peck introduced a resolution appointing member to Jefferson County Public Health Service Professional Advisory Committe and entertained a motion for consideration. A motion was duly made by Legislator Fitzpatrick seconded by Legislator Maxon and there being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Peck introduced a resolution accepting donation on behalf of the Department of Social Services and amending the 2018 County Budget and entertained a motion for consideration. A motion was duly made by Legislator Doldo seconded by Legislator Maxon and there being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Peck introduced a resolution appointing member to Samaritan Summit Village Board of Directors and entertained a motion for consideration. A motion was duly made by Legislator Maxon and seconded by Legislator Nabywaniec. Chairman Peck noted that Legislator Fitzpatrick has served in this capacity with distinction and is an asset to the Summit Village Board. There being no discussion, the Committee agreed to sponsor the resolution as presented.

Chairman Peck noted that the DSS monthly report was not in the agenda packet but will be sent out to Legislators in due course.

There being no further business of the Committee, on a motion by Legislator Maxon seconded by Legislator Doldo and unanimously carried, the meeting was adjourned at 6:20 p.m.
