GENERAL INFORMATION

Primary elections were held on September 11, 1990, for Democratic, Republican and Conservative parties in Jefferson County.

Local Registration day was held on Saturday, October 13, 1990, with 534 persons being registered to vote.

General Election was held on November 6, 1990, for State Ballot Proposal, Governor and Lt. Governor, Comptroller, Attorney General, Justice of Supreme Court, Representative in Congress, State Senator, Member of Assembly, Surrogate Court Judge, Sheriff and town officials to fill vacancies in ten towns.

November 6, 1990, registration figures - 39,826 eligible voters, of this total 25,835 voted or 64.86%

Primary and General election petitions filed - 38

Commissioners ruling was appealed in Supreme Court by Mr. Martusewicz. Supreme Court ruled petitions were invalid, candidate ruled off November ballot on Conservative line.

SPECIAL PROGRAMS:

Schools & Training:

340 Election Inspectors and Alternate Inspectors trained in election procedures at JCC in August 1990

Voting Machine Custodian training in elections set-up and machine repair held in August and October 1990 for 25 custodians.

A special regional training seminar held at HSB in July 1990 by Sequoia Pacific Corporation and sponsored by Jefferson County Board of Elections. Several new custodians received hands on training at this seminar.

Outreach Activities:

Registration of high school juniors and seniors at each school district in county.

Registration forms and counter boxes forwarded to 37 post offices in county so that registration forms would be more available to the public.

Registration forms were placed in area banks and real estate offices.

Informational talks on the electoral process presented to the regional meeting of U.S. Postmasters and Cape Vincent Improvement League.

ACCOMPLISHMENTS:

a second computer terminal was added to this office, thus expediting the time required for handling of registration forms and the requests for absentee ballots. Informational requests on election day by inspectors and others pertaining to voter registration and eligibility to vote were answered in a shorter time.

Commissioners of Elections scheduled and held monthly meetings during 1990. Commissioner Inglehart was elected as President and William McClusky elected as Secretary.
