Scope:

The County of Jefferson, in compliance with New York State Municipal Law #103, is soliciting bids from qualified suppliers to supply various equipment replacement parts, labor and materials to repair and maintain the products listed within.

The intent of this solicitation is to provide a source for the supply of replacement parts and components, utilizing exclusively, Original Equipment Manufacturer (OEM) Parts and labor costs for repair of equipment in use by the County of Jefferson.

Bids will be accepted from <u>Factory Authorized Dealers or repair facilities</u>. A letter shall be provided, if requested, confirming that the bidder is a Factory Authorized Dealer.

The County reserves the right to add additional equipment acquired from any of the manufacturer's listed to the contract. Discount rates for additional equipment will be negotiated at the time of the addition.

Deliveries:

The vendor shall deliver all **stocked items** within twenty-four (24) hours of order placement. The County reserves the right to terminate any contract and use an alternate, should the vendor become unable to perform.

The vendor shall deliver all **non-stocked items** within forty-eight (48) hours of order placement, unless previously authorized by a designated County Employee.

All deliveries shall be made during regular business hours, Monday thru Friday, between the hours of 7:30 AM and 3:00 PM, unless otherwise agreed to by the contractor and the County of Jefferson. Delivery locations are as follows:

Invoice and Payment:

All deliveries shall be acknowledged by the signature of a County employee and Packing Slips shall accompany all deliveries. Invoices shall be submitted to the ordering department monthly.

Price Lists:

Bids will be evaluated on the basis of percent discount from Manufacturer's suggested retail/list price. If price list shows more than one column of prices, bidders are to clearly identify the column and product line to which the discount applies. Discounts must be stated as a single percentage.

Unless the bidder takes specific exception and provides written documentation in support of the exception, any terms and conditions contained in the parts price list(s) submitted shall not take precedence over the terms and conditions specified herein.

Upon request, the Contractor shall provide up to three (3) copies of manufacturer's product catalogs.

It is the preference of the County to have the ability to place orders on-line using a pre-established contract list of parts. To accomplish this, a vendor will be asked to provide an electronic catalog with pricing or provide a URL/Web address that reflects contract pricing, in order to verify the pricing submitted is in compliance with the bid.

Award:

Separate bids will be awarded for each Manufacturer to the supplier offering the highest discount from the manufacturer's list price. All pricing submitted shall be FOB destination. No shipping/delivery charges will be allowed, unless expedited orders are requested by the ordering agency.

The County acknowledges that this bid includes equipment from various manufacturer's and is fully prepared to award this bid to multiple vendors based on the greatest discount offered and lowest labor rate offered.

For example, one award may be made to a Komatsu Dealer specifically for the Komatsu Equipment listed and a separate award made to another vendor who may supply parts for a Vermeer Brush Chipper. Therefore, IT IS NOT NECESSARY TO SUBMIT A BID ON ALL ITEMS LISTED TO BE CONSIDERED FOR AWARD.

VENDORS ARE REQUIRED TO PROVIDE BOTH A DISCOUNT PERCENTAGE <u>AND</u> A LABOR RATE FOR EACH MANUFACTURER BEING BID TO BE ELIGIBLE FOR AWARD.

Equipment Presently Included in this Bid:

Jefferson County reserves the right to delete equipment during the term of this contract at the sole discretion of the County and may add additional equipment to the contract upon agreement of both parties in writing. The County will provide notification to the vendor to enable the vendor to stock the applicable parts.
