## MINIMUM SPECIFICATIONS

### SCOPE OF WORK

It is the intent of Jefferson County to solicit proposals for Hydraulic Pumps, Valves, and Cylinder Repairs and Custom Machine Work Services for the various Jefferson County Departments.

- 1. The Bidder shall be responsible for providing all necessary equipment, labor, materials and hardware for repairing various cylinders and providing custom machine work services as needed. Bidder must be a complete machine shop capable of repairing and manufacturing hydraulic components. Materials costs shall be based on a cost plus percentage mark up.
- 2. If requested, the Bidder shall provide estimates prior to commencing repairs.
- 3. The County of Jefferson is exempt from all Federal and State Taxes and such taxes must not be included in the Bid price.
- 5. Payments cannot be processed until the Bidder has finished the repairs in a satisfactory manner. Payment will be based upon the completion of an invoice which includes your Federal

# Identification

Number. Invoice must contain sufficient data including, but not limited to description of service parts and material/parts costs and labor rate cost.

- 6. Bidder shall bid all groups since award will be made to one (1) bidder for all groups. The award will be based on the lowest cost of labor rate per hour and material/parts percentage.
- 7. Bidder must state normal turnaround time on proposed repair work.
- 8. The bid prices included in the Vendor's proposal shall remain fixed for the initial contract year.
- The Bidder shall provide the County of Jefferson with a certificate of insurance which includes liability, automobile and worker's compensation insurance. The County of Jefferson must be listed as additional insured. (See Item 18 – Page 3h).

#### CONTRACT PRICE ADJUSTMENTS

All prices submitted must remain firm for a period of one hundred twenty (120) days from the date of award. Beginning September 1, 2023 subsequent price adjustments will be considered by the County. All requests for price adjustments must be submitted to the County a minimum of thirty (30) days prior to the date of the requested price adjustment. The change in price structure (increase or decrease) must be based on fluctuations in the latest published Consumer Price Index (CPI) for all urban consumers, as published by the U.S. Department of Labor, Bureau of Labor Statistics which is available at <u>https://stats.bls.gov</u>.

If, during the Contract term, the awarded vendor is unable to meet contractual requirements in whole or in part based on the price structure of the contract, it shall immediately notify the County in writing. The County may, but is not required to, consider an adjustment in the contract terms and/or pricing. Should the County in its sole discretion determine during the Contract term that the contract price structure results in prices which are unreasonable, excessive, or not truly reflective of current market conditions, and no adjustment in the contract terms and/or pricing is mutually agreeable, the County may terminate the contract through written notice to the vendor, purchase from an alternate source, or rebid the contract.

The fact that a bidder (a) has published price lists, rates, or tariffs covering items being procured, (b) has informed prospective customer of proposed or pending publications of new or revised price lists for such items, or (c) has sold the same items to other customers at the same prices being bid, does not constitute, without more, a disclosure within the meaning of paragraph "A" above.

B. The County of Jefferson has made a determination that the goods or services are necessary for the County to perform its functions and that, absent such an exemption, the County of Jefferson would be unable to obtain the goods or services for which the Bid is offered.
