## DETAILED SPECIFICATIONS

#### GASES

- 1. Units of measurement such as (290 cf) should be annotated with the quantity per cylinder or the weight per cylinder so comparisons may be made without researching the item. Price of cylinder must be stated by size and content and shall be for duration of contract term. Price of both the lease and the content will be used to determine the successful bidder among other factors.
- 2. The Successful Bidder agrees and accepts the responsibility to furnish a manifest or delivery slip listing the exact tanks delivered and the exact tanks picked up for refilling; have the documents signed by the recipient and verified by the party conveying the tanks; and to account for all inventory in writing a minimum of one time each twelve month period. To be agreed upon by Jefferson County Highway Motor Equipment Maintenance Supervisor as prepared by the successful bidder.
- 3. The Successful Bidder shall be responsible for:
  - 1. All certification of the cylinders.
  - 2. Ensuring that all cylinders must be in safe operating condition.
  - 3. All transportation of cylinders (tanks) from and to our staging facility as designated by the Motor Equipment Maintenance Foreman.
- 4. The Successful Bidder agrees to supply specialty gases required for welding unusual types of metal or their combinations at the same rate charged for regular contracted gas cylinders.

Bidders shall provide an annual lease rate for each cylinder type.

Note: The monthly inventory and the total column are approximate figures giving the on-hand and usage figures in average form. These are subject to change as the construction levels change.

#### **SUPPLIES**

Requirements Contract. Bidder acknowledges that the Contract that will be entered into as a result of this solicitation will be a Requirements Contract. The County will have no obligation to the Contractor if no items are required. This specification reflects present expectations of those who are planning for the County for the period of the contract.

#### **CONTRACT PRICE ADJUSTMENTS**

All prices submitted must remain firm for a period of one hundred twenty (120) days from the date of award. Beginning September 1, 2023 subsequent price adjustments will be considered by the County. All requests for price adjustments must be submitted to the County a minimum of thirty (30) days prior to the date of the requested price adjustment. The change in price structure (increase or decrease) must be based on fluctuations in the latest published Consumer Price Index (CPI) for all urban consumers, as published by the U.S. Department of Labor, Bureau of Labor Statistics which is available at <a href="https://stats.bls.gov">https://stats.bls.gov</a>.

If, during the Contract term, the awarded vendor is unable to meet contractual requirements in whole or in part based on the price structure of the contract, it shall immediately notify the County in writing. The County may, but is not required to, consider an adjustment in the contract terms and/or pricing. Should the County in its sole discretion determine during the Contract term that the contract price structure results in prices which are unreasonable, excessive, or not truly reflective of current market conditions, and no adjustment in the contract terms and/or pricing is mutually agreeable, the County may terminate the contract through written notice to the vendor, purchase from an alternate source, or rebid the contract.
