#### COMPANY NAME:

Jefferson County is requesting bids for Pumping Services on an as-needed/on-call basis as follows: Tanks located at the Jefferson County Recycling, Highway, and Watertown International Airport Grease Trap and Pit located at Public Safety Facility Oil-Waste Separator located at Jefferson County Highway Oil Separator (In-Ground) located at Watertown International Airport Aviation Waste Fuel Tanks located at the Watertown International Airport

- Tanks range in size from 300 5000 Gallons
- Tanks will be uncovered by County Employees prior to pumping
- Per Gallon Price must include all pumping, cleaning and disposal fees

**NYS PREVAILING WAGE:** All Pricing must be based on prevailing wage laws of NYS per PRC #2023000813.

#### CONTRACT PRICE ADJUSTMENTS

All prices submitted must remain firm for a period of one hundred twenty (120) days from the date of award. Beginning September 1, 2023 subsequent price adjustments will be considered by the County. All requests for price adjustments must be submitted to the County a minimum of thirty (30) days prior to the date of the requested price adjustment. The change in price structure (increase or decrease) must be based on fluctuations in the latest published Consumer Price Index (CPI) for all urban consumers, as published by the U.S. Department of Labor, Bureau of Labor Statistics which is available at <u>https://stats.bls.gov</u>.

If, during the Contract term, the awarded vendor is unable to meet contractual requirements in whole or in part based on the price structure of the contract, it shall immediately notify the County in writing. The County may, but is not required to, consider an adjustment in the contract terms and/or pricing.

Should the County in its sole discretion determine during the Contract term that the contract price structure results in prices which are unreasonable, excessive, or not truly reflective of current market conditions, and no adjustment in the contract terms and/or pricing is mutually agreeable, the County may terminate the contract through written notice to the vendor, purchase from an alternate source, or rebid the contract.

# #2023h-27 – TANK PUMPING SERVICES Iranian Energy Sector Divestment

Contractor hereby represents that said Contractor is in compliance with New York State General Municipal Law Section 103-g entitled "Iranian Energy Sector Divestment", in that said Contractor has not:

Except as otherwise specifically provided herein, every Contractor submitting a bid in response to this Request for Bids must certify and affirm the following under penalties of perjury:

a.
