DETAILED SPECIFICATIONS

HAY FOR MULCH

The Jefferson County Highway Department will purchase clean hay and/or straw for use as mulch on various County road projects. Hay/Straw is to be loaded on a flatbed trailer allowing County crews to pick up and deliver hay to the work sites.

Hay and Straw shall be dry, clean and baled with an average weight of fifty (50) lbs. per bale. Weight shall be calculated on the basis of the material having not more that 15% moisture content Baling shall be accomplished with only natural fiber or plastic twine. Wire tied bales shall <u>not</u> be accepted.

County shall provide at least two days notice for pick-up.

BASIS OF ACCEPTANCE: Acceptance shall be based on inspection by the County Highway Superintendent or his designee for compliance with the materials requirements.

TRAILER AND STAGING SITE FOR PICK UP AT VENDOR LOCATION:

The County will supply a flatbed or van trailer for the Vendor to load. The Vendor will be required to load County vehicles with bales.

Trailer will be towed by a County vehicle to the job site from the pickup point provided by the Vendor. The Pick Up Point must be easily accessible for County vehicles and is subject to approval by the County Highway Superintendent or his designee.

Mileage adjustments are at the discretion of the Highway Superintendent for award of low bid.

DELIVERED TO JEFFERSON COUNTY HIGHWAY DEPT.:

The Vendor may be required to deliver Hay to Jefferson County Highway Dept., 21897 County Route 190, Watertown, NY 13601. Vendor will be required to transfer bales to County owned flatbed or van trailer at time of delivery.

CONTRACT PRICE ADJUSTMENTS

All prices submitted must remain firm for a period of one hundred twenty (120) days from the date of award. Beginning September 1, 2023 subsequent price adjustments will be considered by the County. All requests for price adjustments must be submitted to the County a minimum of thirty (30) days prior to the date of the requested price adjustment. The change in price structure (increase or decrease) must be based on fluctuations in the latest published Consumer Price Index (CPI) for all urban consumers, as published by the U.S. Department of Labor, Bureau of Labor Statistics which is available at https://stats.bls.gov.

If, during the Contract term, the awarded vendor is unable to meet contractual requirements in whole or in part based on the price structure of the contract, it shall immediately notify the County in writing. The County may, but is not required to, consider an adjustment in the contract terms and/or pricing.

Should the County in its sole discretion determine during the Contract term that the contract price structure results in prices which are unreasonable, excessive, or not truly reflective of current market conditions, and no adjustment in the contract terms and/or pricing is mutually agreeable, the County may terminate the contract through written notice to the vendor, purchase from an alternate source, or rebid the contract.

Such a determination shall be made by the County in writing and shall be a public document.
